The foregoing shall constitute the limit of liability of the Raceway for such injuries occurring to me in any Raceway events; I unconditionally release and indemnify the Raceway regardless of the cause and nature of the injury or death. I understand that I must obtain personal medical insurance in order to compete in any of Eagle Raceway's events.

**COMPLIANCE:** The undersigned agrees to abide by all rules and regulations of the Raceway now or hereinafter promulgated. In consideration of the acceptance by the Raceway of this agreement, the undersigned recognizes his obligation to the public and the Raceway, which posts the prize money and conducts the event, and agrees to compete in all events when qualified if humanly possible.
